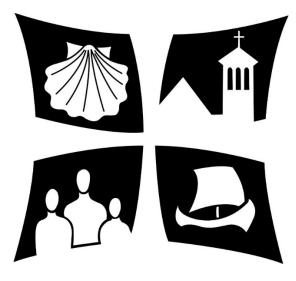

2020 ANNUAL CONGREGATION MEETING MINUTES (ABBREVIATED) SUNDAY, NOVEMBER 15 AT 1:00PM AT ST. JAMES AND VIRTUAL VIA ZOOM

Opening

Kyle Smith, Council President, called the meeting to order. Pastor Mike Allwein led devotions. A quorum was met with 17 members present and over 33 members present virtually. Smith introduced all council members.

Minutes

Minutes of the 2019 congregation meeting were accepted and approved.

Report of Officers and Standing Committees

Treasurer's Report (Church): through September –income of \$1,832,461.37; expenditures of \$1,176,641.53

• Motion to approve report and refer for financial review: Unanimously approved by voice vote.

A concern was raised from the floor regarding chat comments from the Zoom. Smith clarified that chat was not part of the record and that those present were unable to see it and that any comments for the official record must be done via voice communication.

Endowment Fund Report: through September - ending balance of \$699,254.51; distributions of \$16,485.69

• Motion to approve report and refer for financial review: Unanimously approved by voice vote.

Treasurer's Report (ELC): through September – income of \$715,335.70; expenses of \$701,432.50

• Motion to approve report and refer for financial review: Unanimously approved by voice vote.

Standing Committee Reports

Smith solicited questions from the assembly around reports. No questions were raised.

Special Orders

2021 Annual Budget and Mission Plan

Motion to adopt 2021 Mission Plan and Annual Budget coming from Council totaling \$820,840.33 –
 1.6% total increase over last year's budget: Unanimously approved by voice vote.

A motion came from the floor by Lucinda Bringman. Bringman made a motion: <u>That a portion of a loan from</u> the endowment to the worship space refurbishment be repaid in an amount of \$30,000 from the current capital campaign cash on hand. The motion was seconded. <u>Motion carried with 34 yes votes, 21 no votes, 2</u> abstentions.

Sharing Ministry 2021 Budget

• Motion to adopt Sharing Ministry Budget coming from Council for \$22,000: Unanimously approved by voice vote.

Early Learning Center 2021 Budget

• Motion to adopt proposed Early Learning Center Budget coming from Council totaling \$756,450.00 representing a 1% decrease: Unanimously approved by voice vote.

Endowment Fund Committee

• Motion to appoint Lucinda Bringman to Endowment Committee: Approved by voice vote with one abstention.

Congregation Constitution

• Congregation council recommended changes to the congregation's constitutionMotion to approve changes to Constitution coming from Council: Unanimously approved by voice vote.

Election

Voting members to the Lower Susquehanna Synod Assembly in June 2021: Sharon Kaya, Shirley Sanders, Emili Scavitto. A question was raised regarding having 2 females as opposed to a male and a female representative as in the past. Smith indicated that while it was encouraged, it wasn't required. L. Bringman made a motion to refer the motion to council to get an exception from the synod secretary on having 2 females. Motion received a second. After some discussion a vote was held to refer. <u>Motion to refer passed</u> <u>with 40 yes and 17 no votes and one abstention.</u> [update: 2021 actual attendees to Synod Assembly were Sharon Kaya, Alan Hayne and Emili Scavitto]

Sharon Kaya rose to indicate that she wished to add Tim Kyner and Tim Pelc to the Worship and Music report as substitute musicians during the music minister transition.

Closing

Compliments were made for the hard work shown by the church and ELC staff during COVID, appreciation for the capital campaign committee and task force for the work completed so far, appreciation for Lucinda Bringman's service to our synod for many years of service as vice president. 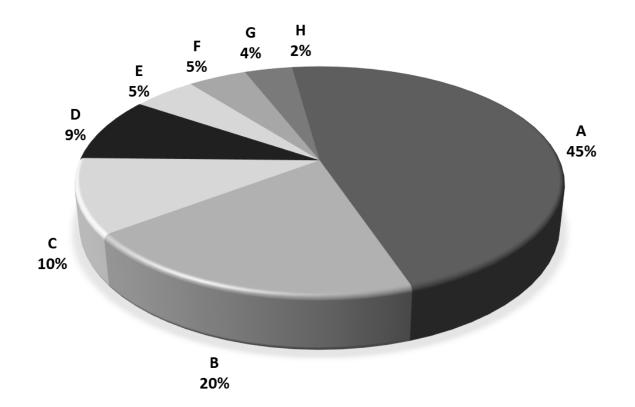

One individual was trained as a Stephen Leader; another as a Stephen Minister. Our supervision group continues to meet monthly.

In all of this, our staff continues to be outstanding in their ongoing commitment to the mission of this congregation. I cannot say enough gratitude for our amazing staff! *Pastor Andrew* continues to be a true colleague and friend on this journey. *Katy Clowney*, our Church Administrator, and *Staci Grimes*, our Administrative Coordinator have shown terrific determination and a lively creative spirit! *Tom Bender* (Building Superintendent) keeps the building in magnificent condition! *Suzan Seibel-Willard* (Early Learning Center Director) does a stellar job in upholding the care for our children at its highest level of attention and safety. *Karen Lentz* (Church Treasurer) quietly comes into the office at calm times to do the critical work of paying bills and keeping a close eye on the finances of the church.

REPORT FROM ASSOCIATE PASTOR, ANDREW GEIB

As I write my annual report, it seems that much of what I reflected in my report from last year applies to this year as well. As with 2020, 2021 has been a time of "*newness*." We have continued to navigate through the things of COVID, discerning what it means for our world, our lives, and our faith – of who God is and how God is present, and of who God calls us to be. We have brought on a new Minister of Music – Jonathan Noel, we said "see ya later" to our Youth Minister – Kristin Slaybaugh, and we have begun to discern what congregational life will look like without Pastor Mike as Lead Pastor with the announcement of his retirement.

Even amidst the quote "*normal*" things of congregational life, nothing is exactly as it was before COVID-19 began to impact our nation two years ago. While our worship attendance continues to grow and visitors enter through the church doors for just about every service, numbers have yet to get to where they were before. There are people we know and love who aren't sitting next to us – some have died and joined their voices to the saints triumphant, some have moved on to another congregation, some have left the Church for good, and some still just aren't yet comfortable gathering in person yet.

As a pastor – one who cares deeply for this congregation and those who are a part of it – this has been difficult to say the least. Regardless of the reasons, I miss those who haven't been around. If you're reading this and you're among those I haven't seen, know that you're among those I miss!

Outside of the things of Church, 2021 has had its challenges for me personally. Like so many of you, I have lost loved ones. My seminary internship supervisor, the Rev. Bill Wiser, died all too soon, shortly after being diagnosed with a rare/aggressive form of cancer. Outside of those pastors connected to me by blood, Pastor Bill was for me, right up there with Pastor Mike, a key mentor in shaping who I am as a pastor and a person. But too, he was a friend and someone I miss deeply. Not too long after Bill's death, we laid to rest my paternal grandfather, the Rev. Richard Geib. For me, one of those deaths I'll never quite get over. I miss our weekly phone calls, his guidance and support, his humanness, and his humor. And then, there was the unexpected/tragic loss of our nine-month-old niece, Isabella Hope Smith. To date, the hardest funeral I have had. I miss her smile and the smiles she brought to everyone around her, and I hate the pain her death has caused our family.

In all these losses, I have done all I can to hold onto the promise of Resurrection Life. Reminding myself amidst the "*Oh, bothers*" of life, that while there comes a day for each of us to leave this world and the ones we love behind, of "*How lucky am I to have something that makes saying goodbye so hard*." – The Gospel according to Winne the Pooh.

It's been said a time or two that the Church is resistant to change. While there are times this is certainly true, the past years a very real test of this notion, it couldn't be further from the truth when it comes to our St. James staff, who continues to amaze me as they adapt to new challenges, creating new ways to do ministry.

Our new Minister of Music, Jonathan, in addition to his high level of musicality – bringing with him a wealth of knowledge and experience – has truly been a joy to work with. He is easy going, lighthearted, and graciously jumps in wherever he can be of help. Our Church Administrator, Katy Clowney, seems to be capable of managing anything that comes across her desk, while somehow keeping track of us pastors. Staci Grimes, our Administrative Coordinator, has taken our social media presence to new heights and seems to always have a thoughtful approach when challenges arise. Our Building Superintendent, Tom Bender – or *Saint Thomas*, as I prefer to call him – continues to be a living image of what Luther deemed *the Priesthood of All Believers* – all of his work to the glory of God. Our treasurer, Karen Lentz, has worked with our elected leadership in creative ways

around the things of finance, often coming in to conduct her work long after others have gone home for the night. And our Early Learning Center Director, Suzan Seibel-Willard, has worked tirelessly along with her staff, doing all she can to keep our children safe and healthy. Please, please, please take the time to express your gratitude to these amazing people when you have the time.

As you know by now and I have already said in this report, Pastor Mike has announced his retirement – his last Sunday as Lead Pastor at St. James being February 27, 2022. Truth be told, there are no words that can fully express my gratitude for being called to work alongside of Pastor Mike over six years ago. He has been a mentor and friend, a listening ear, a colleague, and a steadfast place of support. He has walked with me through ups and downs. We have laughed together and cried together. It has been a joy, a privilege, and an honor to serve beside him. For those who have been here long enough, you know that his call process took place at a difficult time in St. James history – one of anxiety and uncertainty. One shortly after the retirement of two long-term, beloved pastorates – a time when any incoming pastor would have faced some insurmountable odds. In his years of ministry here at St. James, he has visited the sick, buried the dead, baptized the living, and proclaimed the Gospel through word and deed – and he has done so faithfully, out of love of God and love of God's people. May his final days serving as lead pastor be a time of remembrance, recognition, and celebration.

Amidst all of the newness of these past months, while newness can certainly be difficult, it is *newness* itself that is at the core of our theology. We are a resurrection people. In order for new life to take place, so must death. Yet, while the world tells us that the only constant is change, as people of faith, we place our faith in the One who is constant even amidst the change – the One here from the beginning, the Word made flesh, Him crucified and risen.

In times of uncertainty, we are called to do what we are always called to – to walk as yet by faith, trusting that God walks with us wherever we go. *Forgiven and invited to live and love like Jesus*, may we do so according to our Mission Statement – *by being hearers, proclaimers, and doers of the Word*. Come to worship. Reach out to those you haven't seen and invite the stranger. Care for the vulnerable. Feed the hungry. Pray for the sick. Mend relationships that have been damaged – forgiving others as you yourself have been forgiven. Tend to the earth and all of God's creatures big and small. And in all things – love, love, love, love, love.

REPORT FROM MINISTER OF MUSIC, JONATHAN NOEL

Let me begin by saying that this will hardly be an "annual report" as I have been here just over two months at the time of this writing. I am happy to have this opportunity, however, to offer my thanks for your warm welcome and to share my experiences so far.

First, I must commend the search committee, chaired by Kay McDowell, for their work. Sifting through so many applicants and conducting interviews was most certainly a daunting task. The experience from my viewpoint as a candidate was smooth and well-organized and gave me the sense that St James is truly an extraordinary congregation. I am glad to have been chosen for this position and eager to nurture the musical expression of the congregation for years to come. I want to thank the pastors and staff for preparing for my arrival, helping me to acclimate to a new environment, and continuing to answer my many questions.

My first Sunday at the organ was August 22, 2021. Shortly thereafter, the K-5 after-school program started up again. The 20+ children registered for the program are divided grades K-2 and grades 3-5 and I work with each group for half an hour. Currently we are learning hymns and an anthem for the *WaterLife* Service to be held on the Second Sunday of Advent, December 5. This is the first such service since the pandemic began. Not all the children in the after-school program are from St James or even affiliated with a church making this opportunity to talk about and sing about our faith a valuable outreach ministry of this congregation.

The Adult Choir and Martin Luther Choir began their seasons with a combined rehearsal for an anthem on Rally Day, September 12th. Thirty-three participants jump-started the choir season. We are following pandemic protocols of masking and socially-distancing for rehearsals. The choir members are encouraged to sit with their families on Sundays and to come forward for the anthem. The number of participants has slowly risen as comfort levels rise and we all look forward to the day when the choirs will take a more active role in leading the music of a richer, fuller liturgy.

I hope everyone will be patient with me as I learn faces and names. It will take some time to learn about the congregation. Please do not hesitate to introduce (or re-introduce) yourself. Please do let me know if there is something I can do for you. Please let me know if you are interested in participating as an instrumentalist or vocalist. My goal is to find a way for everyone who wishes to participate to do so.

Planning Phase

In Spring 2019, the Capital Campaign Task Force developed a summary of the proposed facility repairs and updates, and invited congregation members to review the summary and participate in an interview or focus group to share their input.

Pastor Renee LiaBraaten, from Renaissance Consulting, conducted confidential interviews and focus groups during May 17-20, 2019. The interviews were designed to capture quantifiable and comparable data in the form of perceptions, opinions, advice, etc. The input from the Planning Phase indicated high regard and gratitude for the dedication of the pastors, staff and lay leadership of the congregation and strong consensus around the need to address necessary repairs.

Congregational approval

A congregational meeting was held at the end of June 2019 during which a written ballot was taken on the following: That St. James Lutheran Church move forward with a three-year Capital Campaign in the fall of 2019 with the financial goal in the range of \$1 Million to raise funds for the proposed repairs and upgrades. The motion was approved by a vote of 175-12.

Campaign results

The Capital Campaign was formally opened during the weekend of November 9–10, 2019. For the first two years of the three-year campaign, we have received \$910,000 and spent \$493,000 for a balance of \$417,000. For the first 9 months of this year we received \$184,000 in income and spent \$92,000. We should be on track for total campaign income of almost \$1.2 million.

Financial results through September 30, 2021 follow below.

We are very appreciative of all the people who volunteered and who have responded with pledges and contributions. We are very thankful to God for all the blessings given to our congregation which enable us to meet this challenge. Over one hundred people volunteered on various committees to make this successful.

Christian Education

Christian Education Committee Mission: *We are to teach the Good News of Jesus Christ in the St. James congregation, providing diverse opportunities for learning for Christians of all ages.*

In August, St. James joined with Christ Lutheran church to host Vacation Bible School for 3 days at Rec Park. Children participated in activities with the "Won't You Be My Neighbor?" theme. Approximately 60 children from the two churches, St. James Early Learning Center and the community participated in the program. Approximately 20 volunteers helped ensure a smooth three days.

After an 18-month hiatus from in-person Sunday School, classes resumed in September. Several classes were meeting virtually or at remote locations prior to that time. Some adult classes continue to meet virtually.

When in-person Sunday School for children resumed in September, we began using a new format for the program. Children ages 2-6th grade, gather together in the nave for an opening lesson. Announcements related to youth activities are made. Mr. Jonathan leads the children in a few songs. Pastor Andrew introduces the bible story for the day. Children are then taken to their classrooms where they have a quick snack and participate in activities related to the story for the week. Activities include projects in art, science, games and building. For the first four weeks of the program, we piloted a new curriculum from Sparkhouse, called "Theme Sunday School." All four weeks centered around the story of the Good Samaritan. Following that, the Holy Moly curriculum was used (also from Sparkhouse), focusing on stories from the Old Testament.

The Christian Ed Committee instituted a "Second Sunday of Service" project at the end of 2014. On the second Sunday of each month, the children from age 4 to grade 6 meet together to engage in a service activity. We resumed the Second Sunday of Service projects in the fall. Children assembled Blessing Bags for people in need and will pack boxes for Operation Christmas Child in November.

The committee is still in need of teachers to help run the Sunday School program for children. In particular, we need additional teachers for the 2-3 year old class, 1st and 2nd grade, 3rd and 4th grade and 5th and 6th grade classes. If you are interested in helping, please contact Pastor Andrew or Julie Dunlop.

We are very grateful to the team of adults who have taught our children and adult classes. We extend heartfelt thanks to those who have led faithfully for many years. Your commitment furthers our mission to share the Good News of Jesus to members, old and new. Thank you!

Early Learning Center Governance

We regretfully accepted the resignation of Wendy Machemer in the spring and would like to publicly thank her for her service and commitment.

The St. James Lutheran Church Early Learning Center is a ministry of service and stewardship of the St. James Lutheran Church. The Center aspires in its operation to provide quality early childhood care and education in a loving Christian environment, to support families in need and to empower the Early Learning Center staff in this mission.

The responsibility of the Early Learning Center Governance Committee is to assure that the Early Learning Center carries out its mission. It reviews, develops, and recommends policies and plans of the Early Learning Center to Council. This year the committee was successful in reviewing and revising the job descriptions for the Assistant Director and Director, COVID-19 Policies and Procedures and the Employee Handbook.

The Center is accredited as Keystone STARS level four, the highest possible rating. During the pandemic, Education and Retention Awards from the state was suspended and replaced with the Pandemic Award for staff working in Early Childhood Education. All staff were eligible.

Enrollment and Staffing: As of September 2021, the Center enrolls approximately 100 full and parttime students and employs 20 staff members full and part time. The Early Learning Center program serves 12 infants, 24 toddlers, 15 preschools, and 19 prekindergarten and 31 school age children. The center is open 11 hours each day requiring full-time and part-time employees. Enrollment operates on a first come, first serve basis depending on the openings in each classroom. The policies for calculating staffing needs are in place and comply with the Pennsylvania Department of Human Services child care regulations.

Financial Assistance: As of September 30, 2021, 24 of our families are receiving financial assistance. This figure is the State funding CCIS as well as our own scholarships. We have more than doubled our scholarship discounts to children and families in need from August 2001 to the present.

Continuing Education: All our staff members are required to fulfill 18 hours of staff training in the required categories for both the Department of Human Services and Keystone Stars as well as training in fire safety, emergency management, first aid, active shooter, mandated reporter, health and safety, civil rights, child and adult food program. Additional trainings in various areas of early childhood development, e.g. learning standards, curriculum, partnerships and families are also required.

Religious Education: Pastor Andrew Geib, Kristin Slaybaugh, and volunteers from the church had weekly Child Care Chapel. This summer our school-age children participated in VBS at the Rec Park. The St. James weekly Youth Group program has invited the After-School age children to participate on Wednesdays as they did last year.

Financial Matters: This year the Center ended in a fiscally sound position despite still having effects from COVID-19. As a result of the pandemic, we were eligible for three rounds of emergency funding as child care was thrown into a crisis both financially and lack of qualified employees. During the pandemic we lost two part-time employees (both considered high risk) and two full-time staff (one whom moved). The 2022 budget has been developed for recommendation to council and to the congregation. It has been recommended that salaries be adjusted by a 4% pay increase and tuition increase.

Accomplishments: Suzan was instrumental in staying in contact with families throughout the pandemic. After reopening we had to close three classrooms at different times and the entire program once due to positive COVID cases. Additional responsibilities have included building a relationship with the Department of Health, track all of the cases, and ensuring state and church policies are successfully carried out. Suzan and her staff have done an excellent job keeping the children safe during this pandemic. Despite the challenges, they continue to provide quality care and education to young children and families and building community and school relationships. Due to COVID-19, in-house and extra activities have been reduced. Children have continued to participate in smaller events that are limited.

It provides a way for the congregation to give, outside of our established methods that will also provide for the long-term continuation of St. James' Mission. Health Committee & Stephen Ministry

Through the Health Committee budget line, health supplies purchased include: AED pads and Stephen Ministry brochures.

As with many areas of ministry, Stephen Ministry has seen several changes during this past year. Probably the most significant is that *SpiriTrust* is no longer serving as the "umbrella" group, overseeing and organizing the program, most specifically as it affects our local area.

The leadership in the Chambersburg group is no longer active, and one trained Stephen Minister from that area has joined us here at St. James. Also, the supervision group that was meeting at St. John Lutheran Church, Hampton is no longer meeting there. Serval members of that group have also joined the supervision group meetings here at St. James.

A training class took place at Gettysburg Presbyterian Church, with Pastor Andrew and Pastor Mike both involved in the teaching of that class. Jesse Holt was trained in that class and is now attending the supervision group here at St. James. Jesse was commissioned as a Stephen Minister in a commissioning ceremony on Sunday morning, November 21, here at St. James.

Paula Shoemaker attended the Stephen Leaders training and is now a Stephen Leader.

The Stephen Leaders here at St. James are Sue Hill, Paula Shoemaker, Jennifer Murphy, Pastor Andrew and Pastor Mike. The supervision group meets every month, which includes check-ins on the relationships with Care Receivers as well as an education component. We currently have 12 trained and active Stephen Ministers.

Our *Journeying Through Grief* program is staffed by previously-trained Stephen Ministers as well as others who have expressed interest and gone through the training to be an advocate for the persons going through difficult times.

Mission Fund

Purpose of the Mission Fund Committee: To solicit suggestions from members of the congregation about organizations or programs to be considered for support and then to evaluate the suggestions and make specific recommendations to Council for distribution of the Mission Fund monies.

The Mission Committee met via zoom on January 19 and by email on March 16, 2021. There was a balance of \$6,225.71 in the Mission Fund to distribute in 2021. An article in the February Messenger solicited suggestions from members of the congregation for organizations and programs to consider funding in 2020. As in past years, the committee decided to support fewer projects with more meaningful amounts rather than many projects with smaller amounts. Given the funds available, the committee recommended to Council three proposed projects.

At the January 19, 2021 Mission Fund meeting, the Mission Fund Committee voted to

- 1) use monies from the first three quarters of a given year from the ELCA Fund A,
- 2) use fourth quarter ELCA Fund A monies from the previous year, and
- 3) transfer these monies to the checking account by December 31^{st} of each year.

This change would give the Mission Fund Committee the exact amount of the Fund A allocation for a given year prior to the January Mission Fund meeting.

In its March 16 report to Council, the Mission Fund Committee recommended that the Congregation Council allocate the indicated amounts from the Mission Fund for the distribution to the following three local and worldwide mission projects which were approved by council:

Because we were not able to gather for in-person midweek Advent services during 2020, the messages were recorded and available online. They were given by Sharon Kaya, Rev. Dick Michael, Bert Waybright, and Natalie Kloster, and focused on Stewardship of Joy, Stewardship of Grace, Stewardship of Wishes/Prayers, and Stewardship of Gifts. The Prayer Shawl Ministry accepts donations of yarn, preferably acrylic knitting worsted weight. Prayer Shawls, Baptism Blankets and Pocket Prayer "Shawls" are handmade by our group. Prayer shawls are given to both members and non-members. Baptism blankets and banners are given to babies and children. Pocket Prayer "Shawls" (a.k.a. *Cross-In-My-Pocket*) are given to new members.

The Prayer Shawl Ministry is branched off an effort started by Janet Bristow and Victoria Galo in 1998.

Care and the love of knitting (and crochet) have been combined into a prayerful ministry that reaches out to those in need of comfort and solace. Many blessings are knitted into every shawl. The knitter begins each shawl with prayers for the recipient. Intentions are continued throughout the creation of the shawl. When the shawl is completed, it is offered in a final ritual before being sent along its way.

As this gift has been sent along, some recipients have continued the kindness by making one themselves and passing it onto someone in need.

Thus, the blessing is rippled from person to person, with both the giver and the receiver feeling the unconditional embrace of a sheltering, mothering God!

The Property Committee is charged with making repairs to Church facilities in-house when possible and lining up outside help as needed.

Projects in process or completed this year include the following.

Slentz House: Joe MacDowell and crew cleaned out food items and donated to SCCAP. Coats were donated to Adams County Prison. A new furnace was installed, exterior was painted, and floors were repaired and/or replaced in kitchen, dining area and downstairs bathroom.

Staircase Enclosure: Center staircase enclosure was installed to improve security for Child Care. Gate on first floor can now remain open.

Fire Alarm: Crouse Electric completed installation of fire alarm system.

Lighting: Crouse Electric has been replacing lighting with energy efficient LED lighting.

Air Conditioning: Several rooms received new air conditioning units.

Repairs/updates to audio video system: Kyle Smith has supervised repairs to units in Nave. A contract has been signed for upgrades.

York Street Doors: Repairs to weather stripping and electronic controls installed.

Parking Lot: Signs were installed on individual spaces to help control/reduce non-church parking.

Replacement Windows: Gary Shaffer has been busy with drawings and planning to replace stained glass windows on south and southeast section of church.

- 1. Kitchen Committee meets with Kathy Tosten and Suzan Seibel-Willard occasionally to check on the maintenance and cleanliness of the kitchen.
- 2. The Kitchen Committee meets on an as needed basis and provides a member to attend Property Committee meetings when needed.
- 3. Paper towel and soap dispenser were mounted by Tom Bender above a sink for hand washing.
- 4. Kathy Tosten provided a bulletin board that is posted in the kitchen for Early Learning Childcare to use.
- 5. A commercial grade microwave will be purchased for the kitchen before the end of 2021.
- 6. A *Kitchen Guidelines* booklet and *Cleanup and Sign-out* forms were created 2019 and will be placed in a notebook in the kitchen hopefully by the end 2021, due to the kitchen not being used during COVID-19.
- 7. An annual kitchen cleaning occurs after the *Fasnacht* event each year. Katy and Staci help announce and solicit volunteers to help the Kitchen Committee. This did not occur during 2021 due to COVID-19.

 - hand washing sign posted by sink
 - directions for use of dishwasher

Landscape Committee Mission: *To engage the St. James community in the stewardship and beautification of the church landscape.*

Landscape Committee's Roles:

- 1. Develop a sustainable volunteer program for maintaining the grounds around the St. James Lutheran Church, Youth House, Slentz House, and parking lots.
- 2. Coordinate stewardship activities such as weeding, mulching, trimming, planting, and removing litter.
- The committee works closely with the Property Committee to maintain plants, trees, shrubs, grass, etc. and check that St. James properties are clear of trash.
- Several events of mulching, trimming, weeding, pruning, and trash clearing were scheduled and completed throughout the year.
- Areas that are maintained by the Landscape Committee are the shrubs around all buildings, plants are trimmed and weeds are removed in parking lot, sidewalks are cleared of weeds including parking exit, Early Learning Childcare walkway and fences are cleared of weeds, and playground rubber area is cleared of weeds.
- Tara contacted Gettysburg Borough Office of Public Works, Rob Harbaugh, in 2020 regarding replacing trees on Stratton Street that show signs of dieback. Rob shared the request with the Bureau Tree Commission that agreed the trees should be replaced. The Borough removed the trees, and the tree commission obtained a quote for replanting trees.
- The committee has been able to maintain landscape at this time without soliciting help for other groups such as the Youth Group or Boy Scouts.
- If the Landscape Committee needs help, Katy and Staci will solicit help via event announcements and sign-ups when appropriate on eBlasts, Messenger, worship announcements, church calendar, and social media.
- One Landscape Committee member attends Property Committee meetings when appropriate.
- Landscape committee meets on an as needed basis.

Social Ministry Committee Mission: *To identify special needs in the local community and to respond with a faithful ministry of monetary assistance and participation.*

Fifth Sunday Servant – Any month with 5 Sundays provides St. James with the opportunity to give support to local non-profit agencies who serve our community. Agencies have included Adams Rescue Mission, school supplies through United Way, the homeless Shelter at South Central Community Action Project.

Food Pantry – On the first Sunday of the month non-perishable food and other items are collected and distributed to the Food Pantry at SCCAP.

Gettysburg C.A.R.E.S. (Combined Area Resources for Emergency Shelter) – Local churches work together to provide shelter and other resources to homeless members of our community. In 2021, C.A.R.E.S. had to operate by using motels instead of the churches. They are expected to open in November again using churches for shelter.

Habitat for Humanity - St. James is a covenant member of the Adams County Chapter of Habitat for Humanity. The Committee and members of the congregation provide refreshments and workers at the building sites. After a delay due to the pandemic, they are again building.

LAMPa (Lutheran Advocacy Mission in Pennsylvania) – is an organization that advocates for Social Programs in Pennsylvania; support is provided through the letter writing campaign during *God's work. Our hands. Sunday.*

Sharing Ministry Benevolence - The Committee offers monetary support to local agencies with monies from trusts provided by former members of St. James. In 2021, organizations included Adams Rescue Mission, Gettysburg C.A.R.E.S., Holiday Family Outreach and others.

Soup Kitchen - The Soup Kitchen supplies daily meals to the homeless and other needy members of our community. In 2021 during the pandemic, they were unable to operate as they did previously and provided box lunches to participants. As St. James was no longer able to offer the 4th Monday meatloaves and other items, the Committee voted to provide funds for the Monday lunches.

Racial Justice Task Force is a new Committee formed to look at racial issues locally and learn what may be done to reduce the problem. In September, the Committee participated in the Heritage Festival.

In 2021 due to the pandemic, we were unable to do dinners at the Seminary. However, we were able to enjoy devotions and dinner with the resident at the Adams Rescue Mission. Hopefully in the future we may be able to again become more involved in the Gettysburg/Adams County community.

In order to fulfill that mission, the Committee has carried out the following activities:

- Sent contributions from Other Projects Line item of \$1,500
 - Source of Life Ministries
 - \$100 for physical therapy treatments for orphanage resident
 - \$300 for septic system reconstruction to Source of Life Ministries
 - Lutheran Immigration and Refugee Support
 - \$850 to LIRS for Afghan refugee support
 - LWR personal care kit supplies of \$250.59
- St. James Quilt Mission highlights:
 - Prepared quilts throughout the year thanks to Lois Allwein, Claire Anderson, Becky Carter, Carol Cook, Sally Crist, Greta Englund, Elizabeth Fair, Pegg Gardner, Brenda Heberling, Barbara Hedrick, Sam Main, Barbara Nicks, Judy Seilhamer, Paula Shoemaker, Ila Verdirame, Sandy Waybrant, Carol Widerman, and Cindy Zepp this mission has carried on through a difficult year.
 - Presented a quilt to Tim and Barbara Braband and Debby Nimtz for their service, commitment, evangelism, and leadership at St. James.
 - Delivered 38 quilts to LWR collection site (New Windsor, MD) in May.
 - Held three *Knot a Quilt* sessions in October to finish 41 assembled quilts over the summer. Quilts will be blessed during the November 14 service and delivered before December.
