

CHURCH VAN PROPOSAL FROM VAN TASK FORCE

Task Force Chair: Alan Haynes

Task Force Members: Daryl Aurand, Pastor Libby Baker-Mikesell, John Doerfler, Daniel

The St. James Van Task Force is recommending that our church consider the purchase of a passenger van to help facilitate:

- Youth Group functions where part of the activity requires transporting to different functions. Currently we rely on several volunteers and multiple vehicles to fulfil our transportation needs.
- Transportation of church members to and from church on Sunday morning.
- Church staff needs (Sam's Club, staff events, etc.)

The Task Force realizes that extra managerial functions would be required to monitor the van usage including scheduling, qualified drivers, maintenance, etc. Because of these extra functions it is recommended that the van management fall under a separate ministry or committee within our church.

The Task Force has inquired about additional insurance coverage through our current provider and got an estimate that is around \$2,500 per year. It is difficult to get an exact annual cost estimate because we do not own the vehicle. To keep within the guidelines of the insurance requirements we were told the following:

- All drivers must be a minimum of 25 years of age.
- All drivers must meet the insurance requirements of the provider.
- The maximum distance for coverage without special notification is 250 miles from Gettysburg.

Not related to the insurance requirements, but related to St. James requirements, include:

- All drivers must pass a background check (Same requirement as CARES).
- There must always be 2 adults in the van when transporting youth.

After discussing van ownership with other churches in our area, the consensus within the Van Task Force was a newer van would best suit our needs for reliability, dependability, and safety. The recommendation from the Van Task Force is that the church acquire a 15 passenger non-CDL van that is 2014 or newer, with less than 80,000 miles.

Regarding parking the van, the Task Force strongly recommends that the van be parked in the church parking lot. Some of the concerns of "offsite" parking are security of the van, potential target for vandalism and keeping the van on the church property would promote utilization of the van.

Finally, the Van Task Force recommends that the purchase of the van be done with ELCA Endowment Fund pooled trust funds.





The Social Ministry Committee oversees the distribution of Sharing Ministry Benevolence funds. These gifts of community support are single checks distributed at the beginning of the year. The Holiday Family Outreach check is distributed in October.

The Emergency Fund item is used some years and not others. It is at the discretion of the Social Ministry Committee to determine how the Emergency Fund monies should be used.

The Sharing Ministry Benevolence Fund is supported solely by interest generated on checking account balances, CDs, and trusts that are in the church's name. The trusts are the largest contributing factor to the available funds in the Sharing Ministry Benevolence Fund, and reflect market performance. The annual distribution dollar amount is determined by the market and interest received in the *previous* year.

REPORT FROM LEAD PASTOR, ANDREW GEIB

For as in one body we have many members, and the members do not all have the same function, so we, though many, are one body in Christ, and individually members one of another.

-Romans 12:4-5

I recently shared an article with our current Council President Alan Haynes, who then passed it on to Council, entitled *Where will our next pastor come from?* The article was written by my first-year seminary field education supervisor, Pastor Rob Myallis, who currently serves Saint Paul Lutheran Church in Lititz.

Throughout its' pages, Pastor Myallis reflects on the current reality of the Church at large – the lack of pastors available for call, the negative impact that politics has had on congregations and the challenges it has caused for clergy, the increased cost of living expenses that has placed many clergy in difficult financial realities, and the unrealistic expectations placed on clergy to be all things to all people at all times. In all of it, the Church's lack of ability to address such issues.

As you would expect, the article has caused a great deal of conversation among local clergy here in the Lower Susquehanna Synod (for good reason). I can tell you, a quick survey of congregations here in Adams County, Lutheran and otherwise, would reflect the painful reality the article describes. Most of our neighboring churches are struggling – struggling to find a pastor (and afford one), struggling to make ends meet, struggling to get people in the pews, struggling to do the ministry God has called them to do in this time and place.

So, pastor, why write about such a reality in your annual report? While I could come up with a whole list of reasons, the most important is because of what Saint Paul writes in his letter to the Romans – as church, we are one body in Christ, individually members one of another. In other words, what happens across the Church impacts all of us. We are all one.

In the countless challenges of ministry described throughout Pastor Myallis' article and others, I am grateful to serve here at St. James. I know Pastor Libby would say the same. We have an amazing staff – not just in their work, but in their hearts, which leads them to do the work that they do. And too, we have (we are) an amazing congregation made up of members of the body of Christ who give of themselves in countless ways, known and unknown, for their neighbors in need.

Some highlights of this work in neighborly love from the past year include welcoming the CARES residents under our roof for the first full cold weather season, the life-giving financial assistance that has come out of our office, our continued work as an RIC congregation, and our first mission team to Tree4Hope in Guatemala. In addition to these ministries we have presided over weddings, buried the saints triumphant, made regular hospital and homebound visits, and tended those other daily pastoral responsibilities.

A few things as we look to the year ahead.

- First, should everything go according to plan, we will begin a recovery ministry here at St. James beginning in January. Following over a year's worth of work and conversation, *Common Ground Gettysburg* will gather in the choir room on the first Monday of every month for worship rooted in the Twelve Step program. It is open for everyone, not simply those in recovery or living in addiction. I am grateful for those here at St. James who have been a part of the process thus far, and for Pastor Tom Scornavacchi of the original *Common Ground* for his gracious support.
- Because of the increased need for affordable housing in our community, along with Pastor Jeremiah of Intersection Church and Pastor Will Hudson and Paul Henderson of the Adams County Rescue Mission, we will be holding a housing summit conversation in February. Following several organizational meetings, our hope is to bring together local resources (churches, social service organizations, businesses, etc.) to see how we might work together to serve the least among us here in Gettysburg. While there is a lot of work to be done, I am excited about the possibilities.
- Our Church Growth Taskforce continues to meet to work on the results we gathered
 during our Church Growth campaign beginning in 2022 with Pastor Nathan from
 Summit Consulting. Current priorities of the taskforce include challenging small groups
 within the congregation to think about how they might include evangelism in their
 current work, working on St. James branding items (stickers, magnets, t-shirts, etc.),
 getting the Common Ground recovery ministry up and running, and guiding members to
 be more invitational in their day to day lives. In essence creating a culture of
 evangelism here at St. James.

If I were to draw our focus to one take away from this year's annual report is this. The world is an increasingly difficult place. Families struggle to keep up with the demands placed on them. We've all been affected by the increased cost of living. The things of politics continue to cause conflict and division. All of which has impacted the Church. Yet, we are truly blessed as a congregation – by each other and by what we do together. The Spirit is alive and well within our walls, guiding us to do God's neighbor loving work in the world. My challenge for us over these next months, individually and as a congregation, is to commit (and recommit) ourselves to the work of the Gospel – to go and tell, make disciples, care for our neighbor in need and the world God made, and in all things love. There are things happening within our family of faith worthy of being shared and there is always room for more.

Siblings in Christ,

Jesus said, "All authority in heaven and on earth has been given to me. Perhaps our own evangelism starts through a personal invitation to church or a community event, starting our own small group ministry, or infusing more evangelism into our current committee responsibilities and structure. REPORT FROM MINISTER OF MUSIC, JONATHAN NOEL

In my first two years on the job, we worked to get buy-in from the kids. That meant making youth group an enjoyable experience and providing a space for fellowship. We've continued to do that this year but have also asked our kids to think about what it means to be a member of St. James Youth Group. Is this just a fun place to hang out and be yourself, or is it place to have important discussions about who we hope to be and how we move through the world? Should we continue to invest in ourselves, or look to do more for our local and global communities? Hopefully this leads to a renovation of purpose.

To help get there, we've invested in some extra curriculums for middle and high school. The first, Actually Fun – Next Level Youth Ministry, puts creative games at the center of our lessons. The second, Gathering Remix, was created by the ELCA and is a companion to the National Youth Gathering we attended this year in New Orleans. Both have helped our kids think about complex spiritual issues in fun ways. While our enrollment at this level remains at roughly 30 kids, our average attendance is up from 14 to 22 so far this year. Our confirmation program has reached new heights, with 18 kids currently attending classes at least once so far this year.

At the K-5 level, Jonathan Noel and I continue to develop our own curriculum, this year around renovation. While renovating our outlook on friendship, confidence, joy, bravery and hard work, we're using the Bible as a blueprint to make sure we don't stray too far from our values. We had 50 kids registered at the start of the year, up from 48, but our average attendance has crept from 42 to 47 kids in the first six weeks of fall youth group.

Chapel Time, a time of Biblical exploration with the kids from the St. James Early Learning Center, expanded from 30 to 60 minutes this year. In the past our Preschool and PreK kids attended together but we felt it was important to separate them so we could cater games and activities to their abilities, providing new opportunities for connection.

Our group continues to expand its national and global mission as well. This year, our K-5 group spearheaded a campaign to raise money for Tree4Hope Academy in Guatemala. We provided a "random acts of kindness" drive in which the kids were asked to report these acts each week. In return, they received a wooden coin worth \$3 that would go toward a child's education in Guatemala.

Our high school group attended National Youth Gathering in New Orleans for the first time since the pandemic. Eight of our best and brightest kids joined Pastor Libby and I learning

how we were created to be brave, authentic, free, disruptive and disciples of God while exploring a new city. We also helped to paint a homeless shelter in the area. Several of our kids returned emboldened to make an imprint in their community. This is largely funded by a church-wide Fastnacht fundraiser that sold roughly 1,700 dozen sugary treats this year.

Roughly 30 kids spent a week at Camp Nawakwa, aided by \$100 and \$200 scholarships from our congregation. Our middle and high school kids regularly attended weekly trips to state parks, trampoline parks, paintball facilities and more during the summer.

We continue to draw large numbers to our popular community events. The Halloween Bash and Breakfast with Santa each draw in roughly 200 people, providing a place of shelter and exciting activity before large community events in Gettysburg. Our space-themed vacation bible school also drew nearly 150 kids and 50-plus teen and adult volunteers. We gathered 110 bikes during our Recycle Bicycle event. These bikes will be fixed up and given to people in need of transportation or recreation in the inner city, as well as overseas.

For the past two years, we measured our success based largely increased registration and attendance. As our growth plateaus during our year of renovation, my aim is to coach our kids to live more into their values as Christians while still enjoying each other's friendship.

Early Learning Center Governance

The St. James Lutheran Church Early Learning Center is a ministry of service and stewardship of the St. James Lutheran Church. The Center aspires in its operation to provide quality early childhood care and education in a loving Christian environment, to support families in need and to empower the Early Learning Center staff in this mission.

The responsibility of the Early Learning Center Governance Committee is to ensure that the Early Learning Center carries out its mission. It reviews, develops and recommends policies and plans of the Early Learning Center to Council. In 2024, a new assistant director, Kim Ellis, was promoted from within the center to assist with center and office responsibilities. The ELC has maintained full enrollment within the Early Learning Center, and very minimal staff turnover. The ELC passed our annual DHS inspection in April 2024, as well as successfully completing one of two drop-in visits, for the year. The ELC successfully completed their redesignation of Keystone STARS level four, for quality care. A STAR four facility focuses on staff credentials, the environment, family involvement, and curriculum.

The ELC purchased an updated curriculum and assessment tool: *Creative Curriculum and Teaching Strategies*. This curriculum has been used in the past in the ELC, but an updated version had to be purchased as a STARS requirement. Along with this new curriculum and assessment tool, we upgraded technology for the teaching staff. iPads were purchased and have been used daily for observation and documentation of the children's development.

The ELC Governance, along with the ELC administration, has made much needed updates to our Parent Handbook which will be available early 2025. The employee handbook will soon follow.

Partnership with the community: Ashley, ELC director, serves on the Ready to Learn committee, 1st 10 committee, the counselor advisory committee and the director networking committee. Working together to bridge the gap between early childcare and the school district.

Enrollment and Staffing: As of October 2024, the Center enrolls approximately 94 full and part-time students and employs 20 staff members full and part-time. The Early Learning Center program serves 7 Infants, 22 Toddlers, 16 Preschooler's, and 17 Prekindergartners, and 31 before & after-school children enrolled in our school age program. The center is opened over 11 hours each day requiring full-time and part-time employees. Enrollment operates on a first-come, first-served basis depending on the openings in each classroom and the time of the submitted application on the waitlist. Our enrollment has been slower then normal over the last few months. We hope to have the classrooms fully enrolled in January 2025. One

classroom remains empty; however, there are plans to launch a pilot program in January 2025. The pilot will be a half-day PreK program, operating from 9:00 a.m. until 12:30 p.m., providing 1 meal (lunch). This program will only operate during the school year and care for 10 PreK children. If it takes off, we will continue next fall taking only children that will be going to kindergarten in the fall of 2026. We have a solid waitlist for children under the age of 3. The policies for calculating staffing needs are in place for times of low enrollment.

We hired 3 new full-time & part-time staff, and we are still in the process of hiring a permanent PreK teacher.

Financial Assistance: As of October 2024, 16 of our families receive financial assistance from State Funding and Child Care Works (CCW). Currently, no families receive ELC scholarships. Three staff members receive employee tuition discounts for their children enrolled in the program. We have 6 children that have IEP or IFSP plans for speech, occupational, and physical therapy, and behavioral problems.

Continuing Education: All our staff members are required to fulfill 18 hours of staff training in the required categories for both the Department of Human Services and Keystone STARS of fire safety, emergency management, first aid, active shooter, mandated reporter, health and safety, child and adult food program and in various areas of early childhood development, e.g. learning standards, curriculum, partnerships and families. Two staff members have exceeded their training hours to receive their CDA's. One of the two is continuing her education, working towards her associate's degree in early childhood education.

Religious Education: Adam Michael, Director of Youth & Family Ministry, and Pastor Libby Baker-Mikesell, host weekly Child Care Chapel on Wednesday mornings with our Preschool and PreK children. Adam has greatly extended and developed the programing that the Preschool and PreK children experience each week. Adam continues to invite the afterschool program children to participate in K-5 Youth Group on Wednesdays.

Financial Matters: This year the Center ended in a fiscally sound position. The 2025 budget has been developed for recommendation to council and to the congregation. We are also participating in the Giving Spree on Nov 7th. The staff do an excellent job providing quality care and education to young children and families and building community and school relationships to improve opportunities for success in the future. We continue to struggle financially to pay our staff a quality and equal wage they deserve. We want to retain and hire quality employees for this field, and it is very hard to do without assistance or raising tuition. We continue to encourage families and staff to advocate for our teaching staff through *Start Strong PA*, and contacting our legislators informing them how important quality childcare is for working families.

Evangelism Committee Mission: To increase our invitation and ministry to neighbors near our church and near our homes; offer outreach to the community using technology; be welcoming to all.

Church Growth Campaign: We are continuing our conversations on helping the congregation become more invitational and welcoming. Included in our discussions are ideas for small group activities such as women's retreats, couples' retreats, small groups, etc. Also to be encouraged is Congregational Storytelling but no specifics have been put in place yet.

Welcome Area: The welcoming space continues to be located at the table outside of the office entrance with the updated trifolds.

Church Directory: Our Instant Church Directory now contains over 350 photos as compared to our printed pictorial 2018 directory with 210 photos. A printed version of our current directory is in process. The Instant Church Directory app has been so successful that the immediate need of a printed copy has diminished. Special thanks to Carole Smith, Cindy Zepp, and church staff for making this effort successful.

Name Tags: The process was simplified allowing members to create and decorate their own name tags, then have them laminated. Storage was made simpler by encouraging members to take their tags home with them. An overwhelming majority are wearing their name tags to church and various events. Alan Hayes, Diane Fulton and Anne Gomer sponsored lanyards for the name tags. Kudos to Scott and Terri Zimmerer for fostering the idea of name tags.

Committee/Worship Information Fair: The information fair was held Sunday, October 27 between services. This fair will be our first one in five years since September 16, 2019. Hopefully it encourages members to get more involved and sign up for various committees and worship responsibilities.

Fellowship Opportunities

- Fall Blessing: Our committee supplies the beverages for the picnic, and in an effort to go green, uses the large coolers for water and encourage members to bring their own place settings.
- Bluegrass Liturgies: We are responsible for the set up/serving/clean-up and beverages for both events in the spring and fall.
- New Members Luncheons/Class: Classes were held on October 29, 2023 and May 19, 2024. Our committee is currently questioning the return of individual sponsors for the

members. Plans to update our word usage from sponsors to mentors and make some changes to make it more of an opportunity to be evangelistic. We would also like to provide new member packets and a checklist of ways to get involved at St. James. There was discussion, too, about sharing a PowerPoint presentation for new member classes. For these luncheons we supply the food, desserts, and beverages for our guests.

- *Midweek Advent Meals:* Meals were held in the dining room November 29, December 6, 13, and 20. We help set-up, label the food contributions, furnish handwritten name tags, and clean up.
- Lenten Meals: The soup & bread meals were held consecutive Wednesdays from
 February 14 thru March 28. We coordinated the assignments of eight soups and six
 breads. Once again, we were involved with the set-up, placing water pitchers and cups
 on the tables, furnishing handwritten name tags, labeling the soup and bread
 contributions, and clean up.
- Dinner Groups: Fifty-one sign-ups were divided into seven active Dinner Groups for 2022-2023 year. Once again, the Summer Dinner Group Picnic was held at Gettysburg Daylilies and Peafowl (Charlie and Anne Gomer's home) on June 21, 2024. Currently due to the QR code, the eBlast advertisement, and pastoral announcements, we had 70 people sign-up to participate in the meaningful fellowship for the coming 2024-2025 year.

Health Committee & Stephen Ministry

Through the Health Committee budget line in 2023/2024, Stephen Ministry Training Manuals & DVDS were purchased to train new Stephen Ministers. The training will be put on hold until the new year.

Also pertaining to the health of the congregation, 3 new AEDs were purchased; two via capital campaign funds and one using funds from the Early Learning Center. An AED and trauma kit will be located on each level of the building, plus in the Youth House.

Stephen Ministry

To whom can you turn when friends and family are not enough in your time of need? There are those in St. James who can listen to your concerns and walk with you during your journey to peace.

Stephen Ministry continues to be an integral part of outreach and care at St. James. The lay group includes several congregants plus Stephen Ministers from other Gettysburg churches who provide personal, distinctly Christian care to people who are experiencing myriad difficulties including, depression, isolation, divorce, a death in the family, illness, the problems of both young families and empty nests, and other life challenges.

Trained Stephen Ministers are matched individually with care receivers through a process that includes the two Stephen Leaders and our pastors. Stephen Ministers each see one (and sometimes two, in special circumstances) care receivers who have requested a Stephen Minister via the pastors or the Stephen Leaders; women visit women and men visit men. Conversations and care-receiver names are confidential; even the group doesn't know. Each relationship is open-ended.

The Stephen Ministers meet every month for group supervision and continuing education. During the past year, the group has hosted speakers from the Adams County Council on Aging and the Adams County Sexual Assault Services along with hearing presentations on grief counseling, caregiver self-care and how to deal with people in a post-Covid society. Like other groups at St. James, Stephen Ministry is subject to attrition as longtime ministers complete their commitments. As such, Stephen Leaders will be seeking those in the congregation who feel a calling to use their faith in ways they never imagined. A new class is scheduled for some time in 2025; are you moved to consider an exciting way to serve God and your congregation?

Purpose of the Mission Fund Committee: To solicit suggestions from members of the congregation about organizations or programs to be considered for support and then to evaluate the suggestions and make specific recommendations to Council for distribution of the Mission Fund monies.

At the January 19, 2021 Mission Fund meeting, the Mission Fund Committee voted to:

- 1) use monies from the first three quarters of a given year from the ELCA Fund A,
- 2) use fourth quarter ELCA Fund A monies from the previous year, and
- 3) transfer these monies to the checking account by December 31st of each year.

This change would give the Mission Fund Committee the exact amount of the Fund A allocation for a given year prior to the January Mission Fund meeting.

There was a balance of \$11, 530 in the Mission Fund for the 2024 distribution. An article in the February *Messenger* solicited suggestions for funding organizations and programs from members of the congregation. The Mission Committee reviewed proposals by email through April. This year we received four proposals. Given the funds available, the committee made a recommendation to Council to fund all proposals.

In its April 17 report to Council, the Mission Fund Committee recommended that the Congregation Council allocate the indicated amounts from the Mission Fund for the distribution to four mission projects:

Council approved the recommendations in April.

We generally consider our recommendations to be for one-time distributions to a given project rather than on-going annual financial support, which St. James does through its other benevolence programs.

Property

The Property Committee makes repairs to Church Facilities in-house when possible and arranges for outside contractors as needed. In addition, they manage the remaining projects for the Capital Campaign. The Property Committee provides set-up and tear down for many congregation events including outdoor worship, church picnics, decorations for Christmas, Halloween, Fasnacht making, Vacation Bible School, Gettysburg C.A.R.E.S. hosting and other events.

Projects in process or completed this year include the following:

Renovation of Rooms 305 and 306: A separating wall was removed, and divider curtains have been installed. Carpet was removed and replaced with new flooring, and walls were painted. The cabinets and youth bathroom were removed and reconfigured for a small kitchenette.

Dining room and storage areas: 22 Round tables (7 foot) were donated by Gettysburg Fire Department, repaired, and are stored in the new storage area. Storage areas in the dining room are mostly complete.

Landscape and exterior: Landscaping around the church includes mulching, pulling weeds and some plantings. Anyone interested in helping should contact Lyne Aurand. Mowing is done by volunteers, primarily Alan and Cathy Haynes. Zimmerman Landscaping are repairing the brick sidewalks. Snow removal is done by Brad Smith and C. E. Williams.

Lighting: Energy efficient light installation is an ongoing building project.

Replacement Windows: We signed a contract with Nick Bair of Stonewood Homes to replace the 16 storm windows on the west side of the building (Stratton Street) for \$126,900, not including lift rental, painting or repair. Installation is expected soon.

Painting and Carpeting: The upper level hall was painted, and carpet installed. Painting and new carpet remain in Rooms 304, 307, 308 and 309. Pastor Andrew's office was also painted.

Closets: New closet areas were created in Room 307 to better store equipment and supplies for the Scouts and Gettysburg C.A.R.E.S.

Quilters: New wall shelving units were installed for added organization.

Elevator: Upgrades have been completed to provide better security of the Early Learning Center.

Security Cameras: Cameras were installed in various locations throughout the church property. Cameras were installed in each classroom, halls and dining room in the Early Learning Center to aid with monitoring classroom safety. Cameras were installed in the upper level at the request of Gettysburg C.A.R.E.S. Other cameras were installed in the halls and exterior of the property for additional security & monitoring measures.

Special thanks to Crouse Electric, Kirk D. Smith Construction, Brad Smith and Glenn Blocher and other businesses and individuals that have done work as a donation or at a reduced rate. Special thanks to our amazing Building Superintendent Tom Bender for his stewardship in St. James ministry.

Renewing God's House to Share God's Love Capital Campaign is now managed by the Property Committee. The campaign started in Oct. 2019 and through Sept. 30, 2023, received \$1,080,808 in contributions plus \$65,362 in gifts in kind and spent \$816,266 for an ending balance of \$264,618 for completion of windows and other projects. This does not include over \$14,000 of investment earnings on campaign funds. In addition, there are restricted building funds with a balance of \$21,803 plus part of the endowment is for building projects. See complete financial report for the Capital Campaign on page 21.

Landscape Committee Mission: To engage the St. James community in the stewardship and beautification of the church landscape.

Landscape Committee's Roles: (1) Develop a sustainable volunteer program for maintaining the grounds around the St. James Church, Youth House, Slentz House (Gettysburg C.A.R.E.S.), and parking lots and (2) Coordinate stewardship activities such as weeding, mulching, trimming, planting, and removing litter.

- 1. The Landscape committee welcomed Diane Fulton as a new member this year and met in early fall to discuss landscape needs.
- 2. The committee works with the Property Committee to maintain walkways, planting beds and trees and checks that St. James properties are clear of litter.
- 3. Two small, raised beds are being maintained near the Slentz House (Gettysburg C.A.R.E.S.) for K-5 Sunday School youth to plant pollinator gardens. The Early Learning Center children water the gardens.
- 4. Several events of composting, mulching, weeding, pruning, and trash removal were scheduled and completed throughout the year.
- 5. The Landscape Committee requests a budget to help cover some of the cost of compost, foundation plants, and weed management. The Landscape Committee and other St. James members donate time, tools, perennials, irrigation supplies and materials for Sunday School pollinator gardens.

A year ago, when we were still the Reconciling in Christ Task Force, we reminded everyone that St. James proudly identifies itself as a "Reconciling in Christ" congregation. We stated that "the people of St. James are proud to be a 'welcoming' congregation. We make a promise to every visitor: when you choose to worship with us, we will greet you warmly.

In his own ministry, Jesus offered God's love to everyone, and he was especially eager to reach people at the margins of society, people like widows, orphans, and tax collectors.

For the baptized, as Paul wrote,

'there is no longer Jew or Greek, there is no longer slave or free, there is no longer male and female; for all of you are one in Christ Jesus.'

The Reconciling in Christ Task Force has now been recognized as a "committee" by church council, and we continue to work with our pastors to assist the whole congregation as it maintains itself as a welcoming church. Over the past year we have met sporadically to address particular challenges. Most visibly, carrying the St. James Church banner, members of the committee took part in the Gettysburg Pride March at the beginning of the summer and were present at a St. James table on the square all day. We have provided tables at some Gettysburg College activities. On several different occasions, Pastors Libby and Andrew shared information with us about specific issues regarding LGBTQ+ individuals in the congregation and asked for our advice. The committee plans to staff a table in the gathering area around November's National Transgender Day of Remembrance. We have also begun discussions with the pastors about how the congregation will worship during Reconciling in Christ Sunday this coming January.

Social Ministry Committee Mission: To identify special needs in the local community and to respond with a faithful ministry of monetary assistance and participation.

Fifth Sunday Servant - Any month with 5 Sundays provides the St. James Community with the opportunity to give support to local non-profit agencies who serve our community. Organizations have included Adams Rescue Mission, SCCAP Homeless Shelter, and Holiday Family Outreach.

Food Pantry - On the first Sunday of the month, non-perishable food goods and other items are collected and distributed to the food pantry at SCCAP.

Gettysburg C.A.R.E.S (Combined Area Resources for Emergency Shelter) - Local churches work together to provide shelter and other resources to homeless members of our community. For the second year, C.A.R.E.S. will be at St. James for the entire season (November-April). Ten local churches as well as a civic organization will provide members to staff the program and provide a daily breakfast.

Habitat for Humanity - St. James is a covenant member of the Adams County Chapter of Habitat for Humanity. The Committee provides refreshments and workers at the building sites. Presently a duplex home is under construction in Littlestown. Volunteers are always needed at the building sites.

LAMPa (Lutheran Advocacy Mission in Pennsylvania) – Advocacy for social programs in Pennsylvania, including letter writing campaigns to local and state officials, advocating for housing and food security. They also sponsor Lutheran Day at the Capital in May.

Sharing Ministry Benevolence - The Committee offers monetary support to local agencies with monies from trusts provided by former members of St. James.

Gettysburg Community Soup Kitchen - The Soup Kitchen supplies daily meals to the homeless and other needy members of the community. They provide boxed lunches to participants. In years past, St. James provided a monthly meatloaf meal. During COVID, the Soup Kitchen reorganized their meal preparations, and prefer monetary donations be made to replace our traditional/previous meal support; The Social Ministry Fund provides an annual donation of \$1,200.

Racial Justice Task Force – Addresses racial issues locally and discusses what may be done to reduce the issues.

Community Meals - The Committee enjoyed devotions and a pizza supper with the residents of the Adams Rescue Mission. We also host a supper with Seminarians each October.

In order to fulfill that mission, the Committee has carried out the following activities:

- Held monthly Zoom meetings as needed.

- Mourn the loss of Pat Crowner, longstanding member of World Outreach, model and mentor to all who champion peace and friendship to neighbors around the world.
- Hosted Reverend Brian Palmer, ELCA's missionary in Totota, Liberia as a guest speaker on June 25th.
